The BioLock+ is the world’s first weatherproof and dustproof, IP65 Certified, biometric access control system capable of operating at the harshest of temperatures (-18°C to 50°C). Using sophisticated micro-electronic technology the BioLock+ secures entry to a home or workplace using fingerprint identification. Each unit operates in stand-alone mode, or networked via a PC/server, and supports 100 fingerprint templates. With an embedded Web-based browser it is easily customized to link individual reads to unique combinations of security clearance and entry, as well as integration to larger access, control and command, and security systems.
